





苏州中方财团控股股份有限公司(中方财团)和新加坡-苏州园区开发财团(新方财团)合资组建中新苏州工业园区开发集团股份有限公司(简称"中新集团",英文简称CSSD,前身为中新苏州工业园区开发有限公司),负责苏州工业园区的开发建设,中新集团为促进中新两国互利合作作出了重大贡献,并取得了良好的经济效益。2021年,中新集团营业收入39.17亿元、归母净利润15.22亿元,在A股上市公司排名前10%。



Suzhou Chinese Consortium Holding Co., Ltd.(Chinese Consortium) and Singapore-Suzhou Park Development Consortium (Singapore Consortium) jointly established CSSD (formerly known as China-singapore Suzhou Industrial Park Development Group Co., Itd.), which is responsible for the development and construction of Suzhou Industrial Park. CSSD makes great contributions to the promotion of mutually beneficial cooperation between China and Singapore and has achieved good economic benefits. In 2021, The operating revenue of CSSD reached 3.917 billion yuan and the net profit returned to the parent reached 1.522 billion yuan, ranking among the top 10% of A-share listed companies.

With the development orientation of "comprehensive intelligent energy service provider", Zooming New Energy is committed to promoting the low-carbon transformation of energy consumption and making clean energy benefit thousands of enterprises and households.





## 质跃期

2018年,中方财团成为园区5家市场竞争类企业之一。

2019年6月,"苏州工业园区股份有限公司"正式更名为"苏州中方财团控股股份有限公司"。

2019年12月20日,中新集团在上海证券交易所挂牌上市。

2020年,首次获得国家母基金支持,与国家先进制造产业投资基金 II 期共同设立地方产业基金——先进制造产业投资(苏州)基金。

In 2018, the Chinese Consortium became one of the first five market competition enterprises in the park.

In June 2019, "Suzhou Industrial Park Co., Ltd." was officially renamed "Suzhou Chinese Consortium Holding Co., Ltd.".

On December 20, 2019, the CSSD was successfully listed in Shanghai Stock Exchange A-share (stock code 601512),

In 2022, supported by the national FOF for the first time, set up local industry investment fund, the advanced manufacturing industry (suzhou) funds.

## 可持续高质量发展期 202

2021年,与15家央企集中签约12个合作项目,揭牌3个重大项目,合作领域包括综合能源服务项目、新能源投资项目、产业投资基金等,总合作金额超100亿元。

2021年、2022年,成功发行10亿元江苏省首支碳中和绿色公司债,也是长三角一体化发展示范区单次发行规模最大的该类债券。

2022年,新增开发、建设、并网分布式光伏项目数量超前三年总和。发起设立5亿规模的数字经济产业基金,服务数字苏州建设。

# SUSTAINABLE DEVELOPMENT WITH HIGH QUALITY PERIOD

In 2021, 12 cooperation projects were signed with 15 central enterprises, including comprehensive energy service projects, new energy investment projects and industrial investment funds, with a total cooperation amount of over 10 billion RMB.

In 2021 and 2022, the first carbon neutral green corporate bond of Jiangsu Province was successfully issued with 1 billion RMB, which is also the largest single issue of such bonds in the Yangtze River Delta Integrated Development Demonstration Zone.

In 2022, the number of newly developed, constructed and grid-connected distributed photovoltaic projects exceeds the sum of the previous three years. Initiate and establish a 500 million scale digital economy industry fund to serve the Digital Suzhou.





2015年始,公司正式开启"产业+资本"双轮驱动的发展新模式,逐步将主业聚焦新能源产业和科创股权两大领域。

2015年4月,中方财团参股的江苏省广电有线信息网络股份有限公司在上交所鸣锣上市(股票代码600959),成功打响中方财团IPO项目战略第一炮。

2016年1月,中方财团控股的中新苏州工业园区开发集团股份有限公司(CSSD)首发申请获证监会通过。同年8月,中方财团参股的江苏银行股份有限公司(股票代码600919)在上交所正式挂牌。时隔六年,A股银行板块再迎新成员。

2017年7月14日,在中方财团股东大会、董事会、监事会上,时任苏州市委副书记、代市长、中方财团董事长李亚平要求继续保持奋发向上的势头,坚持稳中求进、开放创新,不断提升公司发展的质量和效益。



Since 2015, the company has officially started a new development mode driven by "industry + capital", gradually focusing on the new energy industry and science and technology innovation equity.

In April 2015, Jiangsu Province Radio and TelevisionCable Information Network Co., Ltd., a joint venture of the Chinese Consortium, was listed on the Shanghai Stock Exchange (stock code 600959), successfully launching the first strategic shot of the Chinese Consortium's IPO project.

In January 2016, the initial application of China New Suzhou Industrial Park Development Group Co.,Ltd.(CSSD), controlled by the Chinese Consortlum, wasapproved by the CSRC.In August of the same year, Jiangsu Bank Co.,Ltd.(stock code 600919), a joint venture of the Chinese Consortium, was officially listed on the Shanghai Stock Exchange. After a lapse of six years, the A-share banking sector has welcomed new members.

On July 14,2017, Li Yaping, former deputy secretary of Suzhou Municipal Committee, acting mayor and chairman of the Chinese Consortium, demanded to continue maintaining the momentum of striving for progress, persisting in seeking progress while maintaining stability, opening up and innovating, and continuously improving the quality and efficiency of the Company's development in the shareholders'meeting, board of directors and board of supervisors of the Chinese consortium.

In 2008, taking the launch of CSSD listing strategy as an opportunity, the Company actively distributed modern service industry, advanced manufacturing industry, comprehensive real estate industry and other fields, committed to expanding new industrial fields featuring innovative carriers and modern service industries, successively investing in a number of new projects such as China Energy Saving (Suzhou) Environmental Protection Science and Technology Industrial Park Co., Ltd., Suzhou Industrial Park Neighborhood Center Co., Ltd., Suzhou Delta International Logistics Co., Ltd., Suzhou Industrial Park Lantian Thermal Power Co., Ltd., Suzhou Industrial Park Northern Gas Turbine Power Generation Co., Ltd., promoted the development of energy-saving and environmental protection industries and clean energy power generation industries in SIP, strengthened the construction of local brands in logistics and community commerce, increased capital in original projects such as Samsung Electronics, promoted the construction of new Samsung Electronics plants and the upgrading of its products, and supported the "going global" development model of CSSD.



The Chinese Consortium took the lead in establishing a modern corporate governance structure and a standardized and reasonable control pattern among the state-owned enterprises in SIP, which was highly praised by the provincial party committee leaders.

## 初创期

1994年,中方财团前身"苏州工业园区投资实业有限公司"初创成立。次年10月,引进中国粮油食品进出口总公司、中国远洋运输(集团)总公司、中国华能集团公司、中国化工进出口总公司、中国技术进出口总公司、中国长城工业总公司、中国节能投资公司、中央电视台、中国银行信托咨询公司等九家中央企业加盟园区(1997年香港农银加盟),组建"中国·苏州工业园区股份有限公司"。1996年2月,国务院各部委和国家、省、市各级领导在北京人民大会堂举行发起人签约仪式,同年5月举行创立大会。

2000年,中方财团以高度的政治责任感和使命感,顺利推动中新《关于苏州工业园区发展有关事宜的谅解备忘录》中CSSD股比调整有关条款,受让新方财团所持CSSD30%的股份,使中方在园区的份额达到65%。



In 1994, the predecessor of the Chinese Consortium, Suzhou Industrial Park Investment Industry Co., Ltd., was established. In October of the following year, nine central enterprises such as (China National Cereals, Oils and Foodstuffs Import and Export Corporation, China Ocean Shipping (Group) Corporation, China Huaneng Group Corporation, China Chemical Import and Export Corporation, China Technology Import and Export Corporation, China Great Wall Industry Corporation, China Energy Saving Investment Corporation, CCTV, and Bank of China Trust Consulting Corporation) joined the park (Hong Kong Agricultural Bank joined in 1997), established "China Suzhou Industrial Park Co., Ltd." In February 1996, various ministries and commissions of the State Council and leaders at all levels of the state, province and city held a signing ceremony for the sponsors in the Great Hall of the People in Beijing, and a founding meeting was held in May of the same year.

In 2000, with a high sense of political responsibility and mission, the Chinese Consortium successfully pushed forward the relevant provisions of the CSSD share ratio adjustment in the Memorandum of Understanding on Matters Related to the Development of Suzhou Industrial Park between China and Singapore, accepting 30% of the CSSD shares held by the New Consortium, bringing China's share in SIP to 65%.
